### 3. SPECIFIC COVID-19 RESTRICTION AND MITIGATION REQUIREMENTS

<b>THE CLUB HAS COMPLETED A COVIDSafe ACTION PLAN</b>	
The Plan has been submitted to Karting Queensland and where required by law, to the relevant State Government Department. All actions identified as being required to be done to create a COVIDSafe Event and Club facility must be carried prior to and during the Event.	
<b>1.</b>	<b>PERMITTED AND NON-PERMITTED PERSONS</b>
<b>1.1.</b>	<b>No person who has symptoms consistent with COVID-19 (this includes any fever, respiratory symptoms, shortness of breath, sore throat, cough, lack of smell or fatigue) is permitted to attend the Circuit or participate in the Event.</b>
<b>1.2.</b>	<b>Any person who starts to feel unwell or to exhibit symptoms of COVID-19 during the Event must immediately avoid contact with all persons at the Circuit and MUST IMMEDIATELY LEAVE the Circuit.</b>

1.3.	<p>Note – The Organising Club must ensure that the maximum number of people (the combined total of Essential Personnel and Permitted Persons) permitted to gather in total at an Event and in groups in accordance with State Public Health Authority Orders/Directions/Regulations is not exceeded at any time prior to or during the Event.</p> <p><b>Essential Karting Personnel</b> is defined as:</p> <ul style="list-style-type: none"> <li>• Club President, Vice President, Treasurer, Secretary; and</li> <li>• COVIDSafe Officer</li> <li>• Essential Officials identified in Section 1.8 &amp; 1.9 of these Regulations</li> <li>• First Aid Attendant; and</li> <li>• Administration and Access Control Attendant/s.</li> </ul>
1.4.	<p><b>Permitted Persons</b></p> <ul style="list-style-type: none"> <li>• A Licensed Driver (Driver) who has booked their entry in the Event plus a <b>maximum of Unlimited other people per kart</b> who must be either:             <ul style="list-style-type: none"> <li>○ The Parent or Legal Guardian of the Driver; or</li> <li>○ The Participant License Holder for the Driver; or</li> <li>○ A Mechanic whose sole task it is, is to prepare, adjust, repair the kart as may be required;</li> </ul> </li> <li>• A Person who is approved by the Club to supply karting components and provide specialised karting service to any Permitted Persons in attendance at the Activity.</li> </ul>
1.5.	<p><b>Non-Permitted Persons</b> – there is <b>NO GENERAL PUBLIC ACCESS</b> and <b>NO SPECTATORS</b> are permitted to be in attendance.</p>
1.6.	<p>All Permitted Persons in attendance must be the holder of a Karting Australia Licence.</p> <ul style="list-style-type: none"> <li>• For the avoidance of doubt, this Licence can be a Drivers, Participant or Pit Crew Licence.</li> </ul>
1.7.	<p>A Permitted Person attending the Activity must leave the Circuit as soon as they have completed their driving or as soon as their Session is finished, whichever is the sooner.</p>
2.	<p>Note – The number chosen in 2.1 <u>must not exceed the maximum number of people permitted to gather under State Public Health Authority Orders/Directions/Regulations.</u></p> <p><b>SOCIAL DISTANCING AND DENSITY REQUIREMENTS</b></p>
2.1.	<p>Essential Karting Personnel and Permitted Persons are not permitted to gather in groups greater than 500 while in attendance at the Event.</p>
2.2.	<p>Government prescribed Social Distancing measures must always be observed.</p>
2.3.	<p>Permitted Persons <b>MUST NOT</b> park or set their Pit up within 2metres of another Permitted Person's Pit space.</p>
2.4.	<p>The use by Permitted Persons of any indoor facilities (other than toilets and washrooms) is strictly limited by the Density Quotient of the room as included in the Club's COVIDSafe Action Plan.</p>
2.5.	<p>Food service provided at the Event must comply in full with all State Public Health Authority Orders/Directions/Regulations.</p> <ul style="list-style-type: none"> <li>• Hand Hygiene must be available at all food service outlets.</li> <li>• Regular cleaning in accordance with the Club's COVIDSafe Action Plan <b>MUST</b> be carried out throughout the Event.</li> </ul>
3.	<p><b>KARTING AUSTRALIA COVID-19 DECLARATION</b></p>
3.1	<p><b>Under NO circumstances is ANYONE who has been overseas in the previous 14 days or been in contact with a person who is known to be COVID-19 positive, permitted to attend the Circuit.</b></p> <p>All Essential Karting Personnel and Permitted Persons <b>MUST</b>:</p> <ul style="list-style-type: none"> <li>• Complete and submit the <b>Karting Australia COVID-19 Declaration</b> at least 24 hours before the commencement time of the Event; and</li> <li>• Forward to the Club's COVIDSafe Officer, the confirmation email that you receive after submitting the completed COVID-19 Declaration.             <ul style="list-style-type: none"> <li>○ <b>If the confirmation email is not sent to the Club on time, you may not be granted access to the Circuit.</b></li> <li>○ <b>If you have been overseas in the 14 days before the Activity or if you have been in contact with a Covid-19 Positive person, you will not be granted access to the Circuit.</b></li> </ul> </li> </ul> <p><a href="https://kartingaustralia.wufoo.com/forms/ka-scrutineering-record-cairns/">https://kartingaustralia.wufoo.com/forms/ka-scrutineering-record-cairns/</a></p>
4.	<p><b>HYGIENE FACILITIES - TOILET/WASHROOM FACILITIES and HAND SANITISER</b></p>

3.1.	Pit Crew with trolleys Will be given access to the Circuit during Qualifying and Racing.
3.2.	Retrieval of Karts is at the discretion of the Clerk of the Course
3.3.	Pit Crew must only enter the Circuit when permitted by the Grid Marshal or the Clerk of the Course and then only if wearing a <b>HIGH VISIBILITY SAFETY VEST</b> on the upper torso.
