



Practice

Clubs affiliated to Karting Australia are covered by Karting Australia's broad form liability insurance policy, subject to the terms and conditions in place:

The policy provides insurance protection to clubs that conduct official/ permitted kart race events that are conducted in accordance with the Karting Australia rules and regulations and other approved events.

The aim of the Karting Australia's liability policy is to provide protection for legitimate/official club/State/-Karting Australia activities that are conducted in accordance with established practices, rules and regulations.

To this end practice at kart clubs affiliated with Karting Queensland are authorized to conduct practice with the knowledge and approval of the affiliated club's official authorities and in accordance with the details below.

Conditions for participants utilizing practice at Karting Australia track licenced facilities are as follows:

- All users of the circuit must hold a current valid Karting Australia license as outlined in Chapter 4 Competition Rules of the current Karting Australia Manual.
- ☐ Non Licensed drivers must have the correct Karting Australia Exclusion of Liability, Indemnity, Release and Voluntary Assumption of Risk Agreement Disclaimer form completed before performing any activities associated with karting. These practice sessions must be conducted as private practice on hired facilities, must send hire agreement or agreement to the state secretary stating that this practice is not approved by KA/KQ and is an agreement between the hirer and the Club
- All users of the circuit must comply with the Protective clothing regulations as outlined in Chapter 7 technical rules of the current-Karting Australia Manual.
- All Karts must meet the basic Kart Formula as detailed in Chapter 1 Technical rules of the current Karting Australia Manual in order to participate in private practice.
- Track use restrictions as outlined in Chapter 4 Competition Rules are at all times applicable.
- There **MUST** be at least **two (2)** persons at the circuit at all times in order for all practice to be authorized to take place.
- All drivers must be familiar with the Chapter 1 Competition rules of the current Karting

Australia Manual.

- Club authorities are to maintain a practice Identification log recording a licence number and ensure that all participants have completed the appropriate forms and are recorded in that log if participating in practice.
- Any incident must be recorded on the Karting Australia incident report form and submitted to the state secretary within 24hrs.
- Any injuries sustained by participants in all practice are to be recorded in the club practice log book –any injury is to be recorded on the Preliminary Accident Report - any claim for injury is to be completed on the appropriate form and dispatched to Karting Australia's current Insurer as detailed on the claim form, with a copy forwarded to the State Secretary.
- Clubs participating in providing practice facilities and use are to ensure that all member licence holders and visiting license holders are familiar with these conditions and a suitable notice must be displayed to advice of this policy.
- Practice approval is granted to all Karting Queensland affiliated clubs upon the approval of this policy, unless withdrawn by order of the State Executive / Council, and clubs must ensure that details outlined in the dot points of this policy are at all times adhered to in order to facilitate the liability and personal accident policies of the Karting Australia for their licensed members. Non-conformance will result in a ban on practice at that facility for a period of 1 month, continued non-conformance may result in a tribunal hearing between KQ and the Club and a fine being imposed.
